## Direct Filing Addresses for Form I-485, Application to Register Permanent Residence or Adjust Status

**You are applying for adjustment of status under one of the following eligibility categories:**

1. Spouse, parent, unmarried son/daughter under age 21 of a U.S. citizen with either an approved Form I-130 or you are filing Form I-485 together with Form I-130
2. Beneficiary of an approved Form I-130 filed by a qualifying relative
3. Spouse or child of an immigrant who has applied for adjustment of status or has been granted lawful permanent residence through a family sponsored visa category that allows derivative status for spouses and children
4. K-1 fiancé(e) (and K-2 dependents) whose Form I-485 is based on an approved Form I-129F, Petition for Alien Fiancé(e)
5. Beneficiary of an accepted, approved or concurrently filed Form I-360, Petitioner for Amerasian, Widow(er), or Special Immigrant, classified as an Amerasian, a widow(er) of a U.S. citizen who died within the past two (2) years, a Special Immigrant Juvenile, or a Special Immigrant Armed Forces member
6. Applicant, including the spouse or child of a qualifying Cuban principal applicant, who is eligible under the Cuban Adjustment Act of Nov. 2, 1966 (Mark the first box labeled “The Cuban Adjustment Act” under 1.f. Special Programs Based on Certain Public Laws in Part 2 of Form I-485. Do not mark the second box labeled “The Cuban Adjustment Act for battered spouses and children” unless you are an abused spouse or abused child.)

7. Registry applicant filing Form I-485 based on continuous residence in the U.S. since before Jan. 1, 1972
8. Diversity lottery winner eligible to file Form I-485
9. Public interest parolee from certain former Soviet and Southeast Asian countries filing Form I-485 under Public Law 101-167 (the “Lautenberg Amendment”)
10. Registry applicant filing Form I-485 based on birth in the U.S. to a foreign diplomat officer
11. Former diplomat filing Form I-485 under Section 13 of the Immigration Act of 1957
12. Applicant who is a beneficiary of a private bill

A U-based nonimmigrant. You must include a copy of your Form I-797C, Notice of Action, for approval of your U nonimmigrant status, and a copy of your Form I-94, Arrival-Departure Record, and a copy of all pages of your passport with a U nonimmigrant visa.

**You are filing because you are:**

1. The beneficiary of an approved Form I-360, Petition for Amerasian, Widow(er), or Special Immigrant, based on the eligibility category “Battered Spouse/Children,” and you are filing for adjustment of status.
2. A T-based nonimmigrant. You **must** include a copy of your Form I-797C Notice of Action, for approval of your T nonimmigrant status, and a copy of your Form I-94, Arrival-Departure Record, and a copy of all pages of your passport with a T nonimmigrant visa.
3. Abused spouse or abused child of a qualifying Cuban Adjustment Act of Nov. 2, 1966 (CAA), Section 1 (Mark the second box labeled “The Cuban Adjustment

Act for battered spouses and children” under 1.f. Special Programs Based on Certain Public Laws in Part 2 of Form I-485. If you are not an abused spouse or abused child but are eligible under the CAA as a spouse or child, mark the first box labeled “The Cuban Adjustment Act.”)

### **You are filing based on:**

1. A pending or approved Form I-360 for an international organization employee or family member

You must include a copy of the Form I-797 showing that your Form I-360 was accepted or approved.

2. An approved Form I-360 for a:
  - Special immigrant religious worker
  - Panama Canal Company employment
  - U.S. Government in Canal Zone employment;
  - Special immigrant physician; or
  - International broadcasters

You must include a copy of the Form I-797C, Notice of Approval, showing that your Form I-360 was approved.

3. Asylum status
4. Refugee status
5. Status under HRIFA as a dependent
6. A pending or approved Form I-140

You must include a copy of the Form I-797 showing that your Form I-140 was accepted or approved.

7. An approved Form I-526, Immigrant Petition by Alien Entrepreneur. (Note: You cannot file Forms I-526 and I-485 concurrently. You must include a copy of the

Form I-797C, Notice of Approval showing that your Form I-526 was approved.)

#### 8. Liberian Refugee Immigration Fairness.

Send Form I-485, Form I-140, and Form I-907 together to the address listed in the Form I-907 filing instructions.

Do **NOT** file Form I-907 at a USCIS Lockbox facility

**You are filing as an Afghan or Iraqi translator.**

If you are filing Form I-485 based on an **approved** Form I-360 for Afghan or Iraqi translators, you **must** include a copy of the Form I-797C, Notice of Action, showing that your Form I-360 was approved.

(**Note:** You may not concurrently file Forms I-360 and Form I-485 for this classification.)
