REVOCATION OF CERTIFICATION

The Agency, named above, filed a petition in accordance with the provisions of Chapter 71 of the Title 5 of the United States Code and the Regulations of the Federal Labor Relations Authority (Authority). The petition sought to clarify the status of Immigration Judges in the following unit as described in the October 18, 2000, Amendment of Certification in Case No. WA-RP-90056, which reads:

Included:

All Immigration Judges employed by the Executive Office of Immigration

Review, U.S. Department of Justice, throughout the United States.

Excluded:

All other professional and nonprofessional employees, management officials, supervisors, and employees described in 5 U.S.C. 7112(b)(2),

(3), (4), (6) and (7).

The National Association of Immigration Judges, IFPTE Judicial Council 2 (Labor Organization) has been the exclusive representative of the bargaining unit described above.

On April 12, 2022, in *U.S. Dep't of Justice, Executive Office for Immigration Review*, 72 FLRA No. 144 (2022), the Authority issued an Order Dismissing in Part and Denying in Part the Union's Motion for Reconsideration and Denying Motion for Stay. The Authority upheld its' prior findings that Immigration Judges are management officials and direction that they be excluded from the bargaining unit. *Id.* As the bargaining unit consists only of Immigration Judges, and as no evidence was presented to establish that any Immigration Judges are not covered by the Authority's findings, there is no residual unit, and this Revocation of Certification appropriately issues.

Based on the above, and pursuant to the authority vested in the undersigned, the Certification of Representative issued to the National Association of Immigration Judges, IFPTE Judicial Council 2 is revoked.
